1.00 Legal form of the Prantik Welfare Trust

Prantik Welfare Trust was established on 22nd April, 2010 under The Trust Act through a Registered Deed at Sub-register office, Tejgaon, Dhaka performed by 14 nos. of Authors (called as Donor) and received by 13 nos. of Trustee (called as Receiver) for the benefits of unfortunate people of the community (called as Beneficiary). Registered deed marked as "Registration No. IV-6 dated 22-04-2010". The Registered office of the Trust located at 66/A Kadamtala, Bashoboo, Sabujbagh, Dhaka-1214 and total enrollment. of Trustees of Prantik Welfare Trust is 219 as on 30th June 2024

2.00 Aims & Objects of the Trust

- To provide financial assistance for medical treatment of the poor Buddhist who have been suffering from critical and complicated diseases;
- To provide financial assistance to the Children of poor and disadvantaged Buddhist in the country side of Bangladesh for promoting their education, healthcare and family welfare;
- To provide financial assistance for the marriage of the daughter of the poor and disadvantaged Buddhist father and mother;
- 4) To play meaningful role in forming sound mind and noble character of the Buddhist Children, adolescent and youth;
- 5) To arrange periodical seminar and symposium on Buddhist cultures, Philosophy and civilization;
- 6) To provide logistic support for setting up sub-centers of the Trust in the country side for helping local people in organizing co-operatives for community development;
- 7) To provide award and medals and confer citation in the name of the Trust to distinguished personalities
- 8) To provide support to research papers and curriculum of research works;
- 9) To provide all possible assistance to calamity hit people of Bangladesh irrespective of caste and creed;
- 10) To take all possible steps for creating safe environment and climate for the cause of mankind; and
- 11) To welcome contributions to the Trust Fund after its establishment by any well-meaning Buddhist and Charitable Organization of Bodies from Home and Abroad.

The Trust has maintained its accounts on a going Concern basis under the Generally Accepted Accounting Principles (GAAP) of historical cost convention and have been prepared on cash basis (i.e. based on actual Receipts and Payments except accruals.)
