DEED OF TRUST

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. The Trust will be known as "PRANTIK WELFARE TRUST" and it comes into effect with the execution of this Deed of Trust.

2. The Trustees shall hold and possess the Trust money (Trust Fund) in perpetuity for the beneficiaries as specified hereinbefore and shall utilize the interest or profit of Trust Fund, to be kept as long term deposit in any or more scheduled Bank/Banks of Bangladesh which may ensure highest benefit to the Trust as well as shall maintain the administrative cost from the income.

3. The Head Office of the Trust shall be located at 66/A Kadamtala, P.O - Basaboo, P.S - Sabujbag, Dhaka 1214. The Trust, however, may establish

Branch Office/ Offices at place or places wherever and whenever it is found conducive to in the interest of the Trust.

4. This Deed of Trust means "PRANTIK WELFARE TRUST". The Authors of the Trust (donors) shall mean the persons who sponsored the Trust and provided the founding Trust money amounting to Tk.14,00,000.00 (Fourteen Lac) only at its inception.

5. The Authors of the Trust (Donors) shall mean the persons who sponsored the Trust and provided the funding Trust money amounting to Tk.14,00,000.00 (Fourteen Lac) only at its inception.

6. The Trustees shall mean the persons who voluntarily agreed to contribute to the Trust an amount not less than Tk. 50,000/- (Fifty thousand) each towards enrichment of the Trust Fund and subsequent to formation of the Trust, person or persons enrolling as Trustees of the Trust upon payment of taka not less than worth 2.5 (Two and a half) tola of gold.

7. The Trustees together with the founding Authors of the Trust shall administer the Trust in conformity with the aims and objects of the Trust.

8. Any Buddhist desirous of associating himself with the Trust as contributor-member will be permitted to contribute to the Trust Fund at a time or by installments, the installment not being below Tk.5,000/- (Five thousand). If in the course of payment of installments from the time of payment of first installment, the total of such installments amount to the value of not less than 2.5 (Two and a half) tola of gold at the relevant time to be fixed by the Board of Trustees, such contributor-member may apply to the Board of Trustees to be a member of the

Board of Trustees and the Trust Board will take necessary action to make him a Trustee to the Trust, if the applicant's allegiance, commitment and human values is found worthy for consideration. All contributions to the Trust Fund by way of installments shall forthwith be deposited in any or more scheduled Bank/Banks in the name of the Trust and proper printed receipts against such payments shall be given to the contributors.

9. ADMINISTRATIVE BOARD OF TRUSTEES

(1) There shall be an Administrative Board of Trustees consisting of a Chairman, two Vice-Chairmen, one Secretary-General, one Joint Secretary, one Treasurer and six members, who shall be elected from among the alive Authors of the Trust (Donors) and the Trustees.

(2) The Administrative Board of Trustees shall hold office for a period of 2 (Two) years.

(3) The Chairman of the said Administrative Board of the Trustees shall preside over meeting/meetings of Administrative Board of Trustees and general/special meetings of the Board of Trustees (as the case may be).

(4) In the absence of the Chairman, the 1st Vice-Chairman and in absence of 1st Vice Chairman the second Vice-Chairman of the Administrative Board of Trustees shall preside over the said meeting. In absence of the Secretary-General, the Joint Secretary shall perform the duties and responsibilities of the Secretary-General.

(5) The Administrative Board of Trustees shall be responsible for proper, effective and efficient administration of the Trust and all things done and actions

taken by it shall be deemed to have been done and taken by the Board of Trustees and ratified accordingly.

(6) The Administrative Board of Trustees referred to above must act in conformity with the guidelines provided by the Board of Trustees and all important things done or decisions taken must be forthwith brought in writing to the notice of the Members of the Board of Trustees.

(7) Bank account/accounts shall be opened and operated by the Chairman, Secretary-General and Treasurer of the said Administrative Board of Trustees and money can be withdrawn from Bank Accounts under signatures of any two of them.

(8) The Administrative Board of the Trustees during its tenure of office shall form a Body of Advisers drawn from Authors and Trustees and designate one First Senior-Adviser, one Second Senior-Adviser and one Coordinator from the members of Advisers.

(9) Upon formal written request/requests made to the First Senior-Adviser or in his absence to Second Senior-Adviser by the Chairman of the Administrative Board of Trustees on any matter relating to implementation of the aims and objects of the Trust, the said Body shall immediately sit and give its opinion/suggestion to the said Board.

(10) The said Body of Advisers shall perform all its functions and activities with the assistance of the Coordinator.

10. AIMS AND OBJECTS OF THE TRUST :

- (1) To provide financial assistance for medical treatment of the poor Buddhists who have been suffering from critical and complicated diseases;
- (2) To provide financial assistance to the children of the poor and disadvantaged Buddhists in the country-side of Bangladesh for promoting their education, health care and family welfare;
- (3) To provide financial assistance for the marriage of the daughters of the poor and the disadvantaged Buddhist fathers and mothers;
- (4) To play meaningful role in forming sound mind and noble character of the Buddhist children, adolescent and youth;
- (5) To arrange periodical seminars and symposiums on Buddhist Culture, Philosophy and Civilization;
- (6) To provide logistic support for setting up sub-centers of the Trust in the country-side for helping the local people in organizing co-operatives for community development;
- (7) To provide award and medals and confer citations in the name of the Trust to distinguished personalities for their notable contribution in the field of literature, art, science, culture and socio-economic development projects;
- (8) To provide support to research papers and curriculum of research works.

(9) To provide all possible assistance to calamity-hit people of Bangladesh, irrespective of caste and creed;

11. ADMINISTRATION OF THE TRUST :

(2) In case of the numbers of Trustees going down the number of ten at any given time, the Board of Trustees shall take special drive to pursue generous members of the Buddhist Community for becoming Trustee by paying taka not less than the value of 2.5 (two and a half) tola of gold and if this measure is not available for implementation, the said Board shall by majority decision appoint person/persons, as the case may be, from the Buddhist community having allegiance and commitment to the aims and objects of the Trust as member of the Board of Trustees in order to keep the number at minimum level of ten so that the Trust can keep going with its mission in future.

(3) All or any task and powers vested in or exercisable by the Trustees hereunder shall be capable of being performed or exercised by a majority of
